

LOCHHRA EXECUTIVE SUMMARY

August 2011

- For August 2011, WV WORKS cases statewide decreased to 11,349, up 352 cases compared to July's 2011's 10,997 cases.
- Adult WV WORKS cases statewide for August 2011 are 6,368, up 268 cases compared to July's 6,100.
- Child-only cases statewide for August 2011 are 4,981, up 84 cases compared to July's 4,897 cases.
- Total support service payments for August 2011 totaled \$1,163,213, up \$213,590 from July's \$949,623.
- The number of adult cases receiving WV WORKS for less than 12 months is 39.0% (2,484 out of 6,368 cases), which is down from July's 39.1% rate.
- From December 1, 2001 through August 31, 2011, 2,521 WV WORKS cases have closed due to the adult(s) reaching the 60-month limit. Of that amount, 1,558 customers requested an extension of benefits up to an additional 6-month period; 619 of which were approved (for a 39.7% approval rate).

Characteristics of the Current WV WORKS Caseload

August 2011

- √ **4,981** Child-only cases ---- parents not in the home and children living with a relative, or parents in the home, are receiving Medicaid and are excluded from the WV WORKS payment.
- √ **47** Cases currently receiving WV WORKS and received TANF in another state before moving to West Virginia.
- √ **195** Cases where parents are excluded from the payment due to being convicted of a drug-related felony after August 22, 1996.
- √ **1,822** Cases receiving Medicaid but not SNAP.
- √ **49** Cases receiving SNAP but adults not receiving Medicaid.
- √ **1,591** Adults receiving WV WORKS and are employed.
