

LOCHHRA EXECUTIVE SUMMARY

March 2013

- For March 2013, WV WORKS cases statewide decreased to 10,208, down 159 cases compared to February 2013's 10,367 cases.
- Adult WV WORKS cases statewide for March 2013 are 5,279, down 143 cases compared to February 2013's 5,422.
- Child-only cases statewide for March 2013 are 4,929, down 16 case compared to February 2013's 4,945 cases.
- Total support service payments for March 2013 totaled \$856,570, down \$46,730 from February 2013's \$903,300.
- The number of adult cases receiving WV WORKS for less than 12 months data has not been provided by RAPIDS since February 2012, due to data program changes.
- From December 1, 2001 through March 31, 2013, 2,825 WV WORKS cases have closed due to the adult(s) reaching the 60-month limit. Of that amount, 1,701 customers requested an extension of benefits up to an additional 6-month period; 702 of which were approved (for a 41.3% approval rate).

**Characteristics of the
Current WV WORKS Caseload**

March 2013

- √ **4,929** Child-only cases ---- parents not in the home and children living with a relative, or parents in the home, are receiving Medicaid and are excluded from the WV WORKS payment.
- √ **29** Cases currently receiving WV WORKS and received TANF in another state before moving to West Virginia.
- √ **112** Cases where parents are excluded from the payment due to being convicted of a drug-related felony after August 22, 1996.
- √ **1,746** Cases receiving Medicaid but not SNAP.
- √ **83** Cases receiving SNAP but adults not receiving Medicaid.
- √ **1,102** Adults receiving WV WORKS and are employed.
