

LOCHHRA EXECUTIVE SUMMARY

November 2017

- For November 2017, WV WORKS cases statewide decreased to **7,266**, down **99** cases compared to October 2017's **7,365** cases.
- Adult WV WORKS cases statewide for November 2017 are **2,152**, down **100** cases compared to October 2017's **2,252** cases.
- Child-only cases statewide for November 2017 are **5,114**, up **1** case compared to October 2017's **5,113** cases.
- Total support service payments for November 2017 totaled **\$379,871**, down **\$6,700** from October 2017's **\$386,571**.
- From December 1st, 2001 through November 30th, 2017, **3,288** WV WORKS cases have closed due to the adult(s) reaching the 60-month limit. Of that amount, **1,943** customers requested an extension of benefits up to an additional 6-month period; **832** of which were approved (for a **42.8%** approval rate).

- √ 5,114 Child-only cases ---- parents not in the home and children living with a relative, or parents in the home, are receiving Medicaid and are excluded from the WV WORKS payment.
- √ 84 Cases currently receiving WV WORKS and received TANF in another state before moving to West Virginia.
- √ 124 Cases where parents are excluded from the payment due to being convicted of a drug-related felony after August 22, 1996.
- √ 5,289 Cases receiving Medicaid but not SNAP.
- √ 155 Cases receiving SNAP but adults not receiving Medicaid.
- √ 339 Adults receiving WV WORKS and are employed.
