

LOCHHRA EXECUTIVE SUMMARY

April 2020

- For April 2020, WV WORKS cases statewide decreased to **6,191**, down **231** cases compared to March 2020's **6,422** cases.
- Adult WV WORKS cases statewide for April 2020 are **1,526**, down **96** cases compared to March 2020's **1,622** cases.
- Child-only cases statewide for April 2020 are **4,665**, down **135** cases compared to March 2020's **4,800** cases.
- Total support service payments for April 2020 totaled **\$124,161**, down **\$107,867** from March 2020's **\$232,028**.
- From December 1st, 2001 through April 30th, 2020, **3,409** WV WORKS cases have closed due to the adult(s) reaching the 60-month limit. Of that amount, **2,005** customers requested an extension of benefits up to an additional 6-month period; **862** of which were approved (for a **43.0%** approval rate).

April 2020

- √ **4,665** Child-only cases ---- parents not in the home and children living with a relative, or parents in the home, are receiving Medicaid and are excluded from the WV WORKS payment.
- √ **106** Cases currently receiving WV WORKS and received TANF in another state before moving to West Virginia.
- √ **123** Cases where parents are excluded from the payment due to being convicted of a drug-related felony after August 22, 1996.
- √ **6,634** Cases receiving Medicaid but not SNAP.
- √ **200** Cases receiving SNAP but adults not receiving Medicaid.
- √ **129** Adults receiving WV WORKS and are employed.
