

LOCHHRA EXECUTIVE SUMMARY August 2022

- For August 2022, WV WORKS cases statewide increased to **5,303**, up **103** cases compared to July 2022's **5,200** cases.
- Adult WV WORKS cases statewide for August 2022 are **1,283**, up **67** cases compared to July 2022's **1,216** cases.
- Child-only cases statewide for August 2022 are **4,020**, up **36** cases compared to July 2022's **3,984** cases.
- Total support service payments for August 2022 totaled **\$206,946**, up **\$58,683** from July 2022's **\$148,263**.

From December 1st, 2001, through August 31st, 2022, **3,561** WV WORKS cases have closed due to the adult(s) reaching the 60-month limit of that amount, **2,072** customers requested an extension of benefits up to an additional 6-month period; **893** of which were approved (for a **43.1%** approval rate).

Number of requests approved to date: 893

Of the 893 cases approved through August 2022 for extension, 626 were for 6 months, and 267 were for periods of 1-5 months.
