<b><u>About this report:</u></b>								
<b><u>Positives</u></b> are current (active) cases and not cumulative. All positive inmates are placed in isolation.								
<b>Total:</b> cumulative tests; refers to number of tests performed and completed, NOT the number of inmates or residents tested as some may have multiple samples taken.								
<b>Pending:</b> all inmates/residents awaiting test results remain in isolation.								
<b>Quarantine:</b> inmates/residents NOT showing symptoms but separated because they are new intakes, back from a hospital for unrelated reasons, etc.								
<i>The testing of adult inmates and juvenile residents reflects decisions by DCR leadership and facility medical providers, following appropriate guidance and in collaboration with state and local public health authorities.</i>
