## West Virginia Child Care Serious Occurrence, Death and Substantiated Abuse and Neglect in Child Care Report

The Child Care and Development Block Grant (CCDBG) Act of 2014 requires states to make available by electronic means, easily accessible provider-specific information regarding the number of deaths and serious injuries that occur in child care settings each year. The WV DHHR Bureau for Children and Families Division of Early Care and Education, The administrator for CCDBG in West Virginia, will make serious injury and child fatality information available to parents and other stakeholders on a monthly and annual basis. The Licenses reflect the status at the time of the occurrence. A breakdown of data, by providers, follows the state-wide totals.
