

## LOCHHRA EXECUTIVE SUMMARY

### January 2018

- For January 2018, WV WORKS cases statewide decreased to **7,007**, down **87** cases compared to December 2017's **7,094** cases.
- Adult WV WORKS cases statewide for January 2018 are **1,973**, down **61** cases compared to December 2017's **2,034** cases.
- Child-only cases statewide for January 2018 are **5,034**, down **26** cases compared to December 2017's **5,060** cases.
- Total support service payments for January 2018 totaled **\$323,699**, down **\$16,732** from December 2017's **\$340,431**.
- From December 1<sup>st</sup>, 2001 through January 31<sup>st</sup>, 2018, **3,297** WV WORKS cases have closed due to the adult(s) reaching the 60-month limit. Of that amount, **1,946** customers requested an extension of benefits up to an additional 6-month period; **834** of which were approved (for a **42.9%** approval rate).

- √ 5,034 Child-only cases ---- parents not in the home and children living with a relative, or parents in the home, are receiving Medicaid and are excluded from the WV WORKS payment.
- √ 171 Cases currently receiving WV WORKS and received TANF in another state before moving to West Virginia.
- √ 121 Cases where parents are excluded from the payment due to being convicted of a drug-related felony after August 22, 1996.
- √ 5,481 Cases receiving Medicaid but not SNAP.
- √ 156 Cases receiving SNAP but adults not receiving Medicaid.
- √ 277 Adults receiving WV WORKS and are employed.
