Metrics

- Provider PA and clinical edit override requests are responded to within twenty-four hours of receipt.
- Requests are either Approved or Denied with three or fewer correspondences required (includes phone and fax correspondence): 97%, 96.9%, and 96.5% for the months of February, March, and April respectively.
- Only <u>one</u> correspondence was required for an Approval or Denial for Edit Override requests 85% of the time February-April 2019.
