# What is the Providers Clinical Support System (PCSS) Model?

Funded by SAMHSA, the overall mission is to provide training and mentoring for primary care providers in evidence-based practices in the prevention, identification, and treatment of opioid use disorders.





## Providers Clinical Support System (PCSS)

Overall Mission: provide training and mentoring at no cost for health professionals in evidencebased practices in the prevention, identification, and treatment of opioid use disorder and other substance use disorders.





- Primary Care Health Providers
  - Prescribers: physicians, psychiatrists, dentists, nurse practitioners, and physician assistants
  - Allied health professionals—nurses, social workers, psychologists, counselors, pharmacists, etc.

#### Core Curriculum

• **Chronic pain:** Drs. Roger Chou, Kevin Sevarino, and Melissa Weimer (internists, pain experts, addiction specialists) developed a comprehensive core curriculum for primary care providers in the prevention, identification and treatment of opioid use disorders in the context of addressing chronic pain.



• **SUD 101:** Drs. David Fiellin, Larissa Mooney, and Michelle Lofwall created a 22 module course on SUD 101 to provide an overview of clinical practices in the prevention, screening and training of all substance use disorders.




## **Mentoring Program**

- All trainings, resources and clinical coaching provided at <u>no cost</u>.







#### **Pilot Program:**

New Hampshire, North Carolina, Pennsylvania, Virginia, New York, South Carolina and Maryland.

#### **PCSS Implementation Objectives**

- Provide OUD/SUD treatment implementation technical assistance to healthcare and mental health organizations to:
  - Increase <u>acceptability</u> and <u>feasibility</u> of delivery of SUD services, including medications for OUD treatment;
  - Increase <u>readiness</u> to deliver SUD services, including medications for OUD treatment; and
  - Increase the <u>number of individuals receiving SUD services and</u> <u>medications for OUD treatment</u> in healthcare organizations.







#### Pennsylvania Hospital Becomes OUD Treatment Model After Working with PCSS During Pilot Program

Hanover Hospital and its affiliated healthcare clinics has become a model for how a healthcare system that is fully engaged in embracing evidence-based treatment of opioid use disorders can make significant change.

A little more than a year ago, PCSS reached out to Hanover Hospital to participate in a five-state pilot program to create a medication assisted treatment (MAT) program.



Since then, PCSS has worked closely with clinicians, administrators, and support staff to increase understanding of preventing, identifying, and treating OUD. [Read more]
