About this report:								
<i>Inmates</i> are adults in prisons, jails and Community Corrections (work-release) facilities. <i>Residents</i> are youths in Juvenile Services facilities.								
<i>Employee</i> figures reflect testing conducted by DCR's medical services providers, and any offsite testing reported to DCR.								
Positive: current (active) cases; NOT cumulative. All positive inmates are placed in isolation.								
Total: cumulative tests; refers to number of tests performed and completed, NOT the number of inmates or residents tested.								
Pending: all inmates/residents awaiting test results remain in isolation.								
Quarantine: inmates/residents NOT showing symptoms but separated because they are new intakes, back from a hospital for unrelated reasons, etc.								
Inmate false positives to date: BCC (1), CRJ (1), MCC (1), NCRJ (1), PHRJ (1), SCC (1), SCRJ (3), TVRJ (1). Employee false positives: NCF (1). All false positives are moved from the positive/recovered columns to the negative column.								
<i>Testing reflects decisions by DCR leadership and facility medical providers, following appropriate guidance and in collaboration with state and local public health authorities.</i>
