About this report:								
<i>Inmates are adults in prisons, jails and Community Corrections (work-release) facilities. Residents are youths in Juvenile Services facilities.</i>								
<i>Employee figures reflect testing conducted by DCR's medical services providers, and any offsite testing reported to DCR.</i>								
<i>Positive: current (active) cases; NOT cumulative. All positive inmates are placed in isolation.</i>								
<i>Total: cumulative tests; refers to number of tests performed and completed, NOT the number of inmates or residents tested.</i>								
<i>Pending: all inmates/residents awaiting test results remain in isolation.</i>								
<i>Quarantine: inmates/residents NOT showing symptoms but separated because they are new intakes, back from a hospital for unrelated reasons, etc.</i>								
Inmate false positives to date: BCC (1), CRJ (1), MCC (1), NCRJ (1), PHRJ (1), SCC (1), SCRJ (3), TVRJ (1). Employee false positives: BCC (1), NCF (1). All false positives are moved from the positive/recovered columns to the negative column.								
<i>Testing reflects decisions by DCR leadership and facility medical providers, following appropriate guidance and in collaboration with state and local public health authorities.</i>
