| <i>Inmates</i> are adults in prisons, jails and work-release facilities. <i>Residents</i> are youths in Juvenile Services facilities. The figures for HCC and MOCC include their satellite work camps. All inmates are tested upon discharge of their sentences or when granted parole. All necessary notifications are provided when inmates subject to release test positive. | <i>Employee</i> figures reflect testing conducted by DCR's medical services providers, and any offsite testing reported to DCR. ( <b>Note:</b> deaths of positive inmates are not included in this data when medical opinion does not conclude COVID-19 caused or contributed to the death, pending any further medical determination.
