The Internship Program offers a flexible schedule of 20 to 40 hours per week for up to 10 weeks, beginning mid-May 2024 and ending mid-July 2024. Interns receive a competitive wage, and those who choose to work in the Charleston, West Virginia area may opt to take advantage of free housing.

Qualified students must have successfully completed 30 hours of college credit with a minimum 2.50 cumulative grade point average and be eligible to work in the United States without sponsorship. To be considered for the Internship Program, qualified students must submit a completed application form and a copy of their most recent unofficial college transcript by email to OSAJobs@wv.gov. Priority deadline for applications is March 1, 2024.

Student Eligibility

Students will be required to meet the following criteria to be eligible to participate in the Internship Program:

- Completed internship application form submitted by established deadline.
- Eligible to work in the United States without sponsorship.
- Earned a minimum of 30 credit hours prior to internship start date.
- Minimum 3.00 cumulative grade point average.
 - 2.50 cumulative grade point average will be accepted with a reference letter.

Student Placement

Most internship opportunities will be offered in Charleston, West Virginia (Kanawha County). Housing for students will be offered in this area at no additional cost to the student.
