WHO'S ELIGIBLE?

To be eligible, applicants must meet the following guidelines:

QUALIFIED APPLICANTS

- Pregnant women
- Women breastfeeding an infant up to the infant's first birthday
- Postpartum women up to six months after delivery or end of pregnancy
- Infants up to their first birthday
- Children from age one until their fifth birthday

INCOME

- Household income no more than 185% of the federal poverty income guidelines
- Families that qualify for the following programs automatically qualify based on income:
 - Medicaid
 - WV Works
 - SNAP

NUTRITION RISK

- Medical-based or dietary-based risk or condition
- Nutrition assessment will be completed at the WIC clinic
