LOCHHRA EXECUTIVE SUMMARY April 2012

- For April 2012, WV WORKS cases statewide increased to 10,597, up 295 cases compared to March 2012's 10,302 cases.
- Adult WV WORKS cases statewide for April 2012 are 5,573, up 202 cases compared to March's 5,371.
- Child-only cases stateside for April 2012 are 5,024, up 93 cases compared to March's 4,931 cases.
- Total support service payments for April 2012 totaled \$1,441,423, up \$180,754 from March's \$1,260,669.
- The number of adult cases receiving WV WORKS for less than 12 months data has been provided by RAPIDS since the February 2012 due to program changes.
- From December 1, 2001 through April 31, 2012, 2,636 WV WORKS cases have closed due to the adult(s) reaching the 60-month limit. Of that amount, 1,618 customers requested an extension of benefits up to an additional 6-month period; 657 of which were approved (for a 40.6% approval rate).
