

LOCHHRA EXECUTIVE SUMMARY April 2022

- For April 2022, WV WORKS cases statewide decreased to **5,377**, down **54** cases compared to March 2022's **5,431** cases.
- Adult WV WORKS cases statewide for April 2022 are **1,289**, down **52** cases compared to March 2022's **1,341** cases.
- Child-only cases statewide for April 2022 are **4,088**, down **2** cases compared to March 2022's **4,090** cases.
- Total support service payments for April 2022 totaled **\$136,104**, down **\$18,713** from March 2022's **\$154,817**.

From December 1st, 2001, through April 30th, 2022, **3,543** WV WORKS cases have closed due to the adult(s) reaching the 60-month limit of that amount, **2,066** customers requested an extension of benefits up to an additional 6-month period; **891** of which were approved (for a **43.1%** approval rate).

- 4,088** Child-only cases ---- parents not in the home and children living with a relative, or parents in the home, are receiving Medicaid and are excluded from the WV WORKS payment.
- 250** Cases currently receiving WV WORKS and received TANF in another state before moving to West Virginia.
- 104** Cases where parents are excluded from the payment due to being convicted of a drug-related felony after August 22, 1996.
- 6,989** Cases receiving Medicaid but not SNAP.
- 224** Cases receiving SNAP but adults not receiving Medicaid.
- 87** Adults receiving WV WORKS and are employed.
