

LOCHHRA EXECUTIVE SUMMARY

December 2020

- For December 2020, WV WORKS cases statewide decreased to **5,814**, **down 40** cases compared to November 2020's **5,854** cases.
- Adult WV WORKS cases statewide for December 2020 are **1,528**, up **4** cases compared to November 2020's **1,524** cases.
- Child-only cases statewide for December 2020 are **4,286**, down **44** cases compared to November 2020's **4,330** cases.
- Total support service payments for December 2020 totaled **\$110,595**, up **\$2,329** from November 2020's **\$108,266**.
- From December 1st, 2001 through December 31st, 2020, **3,450** WV WORKS cases have closed due to the adult(s) reaching the 60-month limit. Of that amount, **2,022** customers requested an extension of benefits up to an additional 6-month period; **870** of which were approved (for a **43.0%** approval rate).

December 2020

- √ **4,286** Child-only cases ---- parents not in the home and children living with a relative, or parents in the home, are receiving Medicaid and are excluded from the WV WORKS payment.
- √ **312** Cases currently receiving WV WORKS and received TANF in another state before moving to West Virginia.
- √ **106** Cases where parents are excluded from the payment due to being convicted of a drug-related felony after August 22, 1996.
- √ **6,796** Cases receiving Medicaid but not SNAP.
- √ **207** Cases receiving SNAP but adults not receiving Medicaid.
- √ **98** Adults receiving WV WORKS and are employed.
