

LOCHHRA EXECUTIVE SUMMARY

January 2019

- For January 2019, WV WORKS cases statewide decreased to **6,612**, down **64** cases compared to December 2018's **6,676** cases.
- Adult WV WORKS cases statewide for January 2019 are **1,626**, down **60** cases compared to December 2018's **1,686** cases.
- Child-only cases statewide for January 2019 are **4,986**, down **4** cases compared to December 2018's **4,990** cases.
- Total support service payments for January 2019 totaled **240,782**, down **\$14,031** from December 2018's **\$254,813**.
- From December 1st, 2001 through January 31st, 2019, **3,357** WV WORKS cases have closed due to the adult(s) reaching the 60-month limit. Of that amount, **1,975** customers requested an extension of benefits up to an additional 6-month period; **847** of which were approved (for a **42.9%** approval rate).

January 2019

- √ **4,986** Child-only cases ---- parents not in the home and children living with a relative, or parents in the home, are receiving Medicaid and are excluded from the WV WORKS payment.

- √ **49** Cases currently receiving WV WORKS and received TANF in another state before moving to West Virginia.

- √ **108** Cases where parents are excluded from the payment due to being convicted of a drug-related felony after August 22, 1996.

- √ **6,096** Cases receiving Medicaid but not SNAP.

- √ **185** Cases receiving SNAP but adults not receiving Medicaid.

- √ **243** Adults receiving WV WORKS and are employed.
