

LOCHHRA EXECUTIVE SUMMARY

July 2014

- For July 2014, WV WORKS cases statewide decreased to 8,792, down 82 cases compared to June 2014's 8,874 cases.
- Adult WV WORKS cases statewide for July 2014 are 3,895, down 90 cases compared to June 2014's 3,985 cases.
- Child-only cases statewide for July 2014 are 4,897, up 8 cases compared to June 2014's 4,889 cases.
- Total support service payments for July 2014 totaled \$614,278, down \$259,681 from June 2014's \$873,959.
- From December 1, 2001 through July 31st, 2014, 3,038 WV WORKS cases have closed due to the adult(s) reaching the 60-month limit. Of that amount, 1,788 customers requested an extension of benefits up to an additional 6-month period; 756 of which were approved (for a 42.3% approval rate).

- √ 4,897 Child-only cases ---- parents not in the home and children living with a relative, or parents in the home, are receiving Medicaid and are excluded from the WV WORKS payment.
- √ 74 Cases currently receiving WV WORKS and received TANF in another state before moving to West Virginia.
- √ 98 Cases where parents are excluded from the payment due to being convicted of a drug-related felony after August 22, 1996.
- √ 2,010 Cases receiving Medicaid but not SNAP.
- √ 45 Cases receiving SNAP but adults not receiving Medicaid.
- √ 1,101 Adults receiving WV WORKS and are employed.
