

## LOCHHRA EXECUTIVE SUMMARY

### May 2019

- For May 2019, WV WORKS cases statewide decreased to **6,428**, down **1** case compared to April 2019's **6,429** cases.
- Adult WV WORKS cases statewide for May 2019 are **1,499**, up **22** cases compared to April 2019's **1,477** cases.
- Child-only cases statewide for May 2019 are **4,929**, down **23** cases compared to April 2019's **4,952** cases.
- Total support service payments for May 2019 totaled **\$291,929**, up **\$43,150** from April 2019's **\$248,779**.
- From December 1<sup>st</sup>, 2001 through May 31<sup>st</sup>, 2019, **3,370** WV WORKS cases have closed due to the adult(s) reaching the 60-month limit. Of that amount, **1,981** customers requested an extension of benefits up to an additional 6-month period; **854** of which were approved (for a **43.1%** approval rate).

- √ **198** Cases currently receiving WV WORKS and received TANF in another state before moving to West Virginia.
- √ **107** Cases where parents are excluded from the payment due to being convicted of a drug-related felony after August 22, 1996.
- √ **6,192** Cases receiving Medicaid but not SNAP.
- √ **180** Cases receiving SNAP but adults not receiving Medicaid.
- √ **242** Adults receiving WV WORKS and are employed.
