

LOCHHRA EXECUTIVE SUMMARY

May 2020

- For May 2020, WV WORKS cases statewide decreased to **6,144**, down **47** cases compared to April 2020's **6,191** cases.
- Adult WV WORKS cases statewide for May 2020 are **1,542**, up **16** cases compared to April 2020's **1,526** cases.
- Child-only cases statewide for May 2020 are **4,602**, down **63** cases compared to April 2020's **4,665** cases.
- Total support service payments for May 2020 totaled **\$93,594**, down **\$30,567** from April 2020's **\$124,161**.
- From December 1st, 2001 through May 31st, 2020, **3,410** WV WORKS cases have closed due to the adult(s) reaching the 60-month limit. Of that amount, **2,005** customers requested an extension of benefits up to an additional 6-month period; **862** of which were approved (for a **43.0%** approval rate).

- √ 4,602 Child-only cases ---- parents not in the home and children living with a relative, or parents in the home, are receiving Medicaid and are excluded from the WV WORKS payment.
- √ 109 Cases currently receiving WV WORKS and received TANF in another state before moving to West Virginia.
- √ 121 Cases where parents are excluded from the payment due to being convicted of a drug-related felony after August 22, 1996.
- √ 6,638 Cases receiving Medicaid but not SNAP.
- √ 201 Cases receiving SNAP but adults not receiving Medicaid.
- √ 121 Adults receiving WV WORKS and are employed.
