

LOCHHRA EXECUTIVE SUMMARY

November 2011

- For November 2011, WV WORKS cases statewide increased to 11,113, down 170 cases compared to October 2011's 11,283 cases.
- Adult WV WORKS cases statewide for November 2011 are 6,155, down 154 cases compared to October's 6,309.
- Child-only cases stateside for November 2011 are 4,958, down 16 cases compared to October's 4,974 cases.
- Total support service payments for November 2011 totaled \$1,182,043, down \$5,749 from October's \$1,187,792.
- The number of adult cases receiving WV WORKS for less than 12 months is 39.2% (2,410 out of 6,155 cases), which is similar to October's 39.2% rate.
- From December 1, 2001 through November 30, 2011, 2,566 WV WORKS cases have closed due to the adult(s) reaching the 60-month limit. Of that amount, 1,580 customers requested an extension of benefits up to an additional 6-month period; 629 of which were approved (for a 39.8% approval rate).

- √ **4,958** Child-only cases ---- parents not in the home and children living with a relative, or parents in the home, are receiving Medicaid and are excluded from the WV WORKS payment.
- √ **96** Cases currently receiving WV WORKS and received TANF in another state before moving to West Virginia.
- √ **195** Cases where parents are excluded from the payment due to being convicted of a drug-related felony after August 22, 1996.
- √ **1,754** Cases receiving Medicaid but not SNAP.
- √ **34** Cases receiving SNAP but adults not receiving Medicaid.
- √ **1,509** Adults receiving WV WORKS and are employed.
