

LOCHHRA EXECUTIVE SUMMARY

November 2012

- For November 2012, WV WORKS cases statewide decreased to 10,622, down 104 cases compared to October 2012's 10,726 cases.
- Adult WV WORKS cases statewide for November 2012 are 5,654, down 51 cases compared to October's 5,705.
- Child-only cases statewide for November are 4,968, down 53 cases compared to October's 5,021 cases.
- Total support service payments for November 2012 totaled \$988,050, down \$144,538 from October's \$1,132,588.
- The number of adult cases receiving WV WORKS for less than 12 months data has not been provided by RAPIDS since the February 2012, due to data program changes.
- From December 1, 2001 through November 30, 2012, 2,758 WV WORKS cases have closed due to the adult(s) reaching the 60-month limit. Of that amount, 1,669 customers requested an extension of benefits up to an additional 6-month period; 683 of which were approved (for a 40.9% approval rate).

- √ **4,968** Child-only cases ---- parents not in the home and children living with a relative, or parents in the home, are receiving Medicaid and are excluded from the WV WORKS payment.
- √ **38** Cases currently receiving WV WORKS and received TANF in another state before moving to West Virginia.
- √ **163** Cases where parents are excluded from the payment due to being convicted of a drug-related felony after August 22, 1996.
- √ **1,801** Cases receiving Medicaid but not SNAP.
- √ **93** Cases receiving SNAP but adults not receiving Medicaid.
- √ **1,233** Adults receiving WV WORKS and are employed.
