

## LOCHHRA EXECUTIVE SUMMARY October 2022

- For October 2022, WV WORKS cases statewide decreased to **5,342**, down **3** cases compared to September 2022's **5,345** cases.
- Adult WV WORKS cases statewide for October 2022 are **1,371**, up **41** cases compared to September 2022's **1,330** cases.
- Child-only cases statewide for October 2022 are **3,971**, down **44** cases compared to September 2022's **4,015** cases.
- Total support service payments for October 2022 totaled **\$200,979**, up **\$2,443** from September 2022's **\$198,536**.

From December 1<sup>st</sup>, 2001, through October 31<sup>st</sup>, 2022, **3,566** WV WORKS cases have closed due to the adult(s) reaching the 60-month limit of that amount, **2,073** customers requested an extension of benefits up to an additional 6-month period; **893** of which were approved (for a **43.1%** approval rate).

- 221** Cases currently receiving WV WORKS and received TANF in another state before moving to West Virginia.
- 98** Cases where parents are excluded from the payment due to being convicted of a drug-related felony after August 22, 1996.
- 6,996** Cases receiving Medicaid but not SNAP.
- 224** Cases receiving SNAP but adults not receiving Medicaid.
- 66** Adults receiving WV WORKS and are employed.
