

LOCHHRA EXECUTIVE SUMMARY

September 2011

- For September 2011, WV WORKS cases statewide increased to 11,422, up 73 cases compared to August's 2011's 11,349 cases.
- Adult WV WORKS cases statewide for September 2011 are 6,452, up 84 cases compared to August's 6,368.
- Child-only cases stateside for September 2011 are 4,970, down 11 cases compared to August's 4,981 cases.
- Total support service payments for September 2011 totaled \$1,014,888, down \$148,325 from August's \$1,163,213.
- The number of adult cases receiving WV WORKS for less than 12 months is 39.4% (2,545 out of 6,452 cases), which is up from August's 39.0% rate.
- From December 1, 2001 through September 30, 2011, 2,535 WV WORKS cases have closed due to the adult(s) reaching the 60-month limit. Of that amount, 1,563 customers requested an extension of benefits up to an additional 6-month period; 621 of which were approved (for a 39.7% approval rate).

- √ **4,970** Child-only cases ---- parents not in the home and children living with a relative, or parents in the home, are receiving Medicaid and are excluded from the WV WORKS payment.
- √ **68** Cases currently receiving WV WORKS and received TANF in another state before moving to West Virginia.
- √ **193** Cases where parents are excluded from the payment due to being convicted of a drug-related felony after August 22, 1996.
- √ **1,786** Cases receiving Medicaid but not SNAP.
- √ **52** Cases receiving SNAP but adults not receiving Medicaid.
- √ **1,576** Adults receiving WV WORKS and are employed.

Number of requests for extension received to date: 1,563

Number of request approved to date: 621

Of the 621 cases approved through September 2011 for extension, 457 were for 6 months, and 164 were for periods of 1-5 months.
