

LOCHHRA EXECUTIVE SUMMARY

August 2018

- For August 2018, WV WORKS cases statewide increased to **6,728**, up **63** cases compared to July 2018's **6,665** cases.
- Adult WV WORKS cases statewide for August 2018 are **1,721**, up **18** cases compared to July 2018's **1,703** cases.
- Child-only cases statewide for August 2018 are **5,007**, up **45** cases compared to July 2018's **4,962** cases.
- Total support service payments for August 2018 totaled **\$263,412**, up **\$12,387** from July 2018's **\$251,025**.
- From December 1st, 2001 through August 31st, 2018, **3,337** WV WORKS cases have closed due to the adult(s) reaching the 60-month limit. Of that amount, **1,965** customers requested an extension of benefits up to an additional 6-month period; **845** of which were approved (for a **43.0%** approval rate).

- √ **5,007** Child-only cases ---- parents not in the home and children living with a relative, or parents in the home, are receiving Medicaid and are excluded from the WV WORKS payment.
- √ **132** Cases currently receiving WV WORKS and received TANF in another state before moving to West Virginia.
- √ **107** Cases where parents are excluded from the payment due to being convicted of a drug-related felony after August 22, 1996.
- √ **5,821** Cases receiving Medicaid but not SNAP.
- √ **179** Cases receiving SNAP but adults not receiving Medicaid.
- √ **275** Adults receiving WV WORKS and are employed.
