

LOCHHRA EXECUTIVE SUMMARY

December 2018

- For December 2018, WV WORKS cases statewide decreased to **6,676**, down **13** cases compared to November 2018's **6,689** cases.
- Adult WV WORKS cases statewide for December 2018 are **1,686**, down **14** cases compared to November 2018's **1,700** cases.
- Child-only cases statewide for December 2018 are **4,990**, up **1** case compared to November 2018's **4,989** cases.
- Total support service payments for December 2018 totaled **254,813**, down **\$15,217** from November 2018's **\$270,030**.
- From December 1st, 2001 through December 31st, 2018, **3,353** WV WORKS cases have closed due to the adult(s) reaching the 60-month limit. Of that amount, **1,971** customers requested an extension of benefits up to an additional 6-month period; **847** of which were approved (for a **43.0%** approval rate).

- √ **4,990** Child-only cases ---- parents not in the home and children living with a relative, or parents in the home, are receiving Medicaid and are excluded from the WV WORKS payment.
- √ **47** Cases currently receiving WV WORKS and received TANF in another state before moving to West Virginia.
- √ **108** Cases where parents are excluded from the payment due to being convicted of a drug-related felony after August 22, 1996.
- √ **6,125** Cases receiving Medicaid but not SNAP.
- √ **184** Cases receiving SNAP but adults not receiving Medicaid.
- √ **283** Adults receiving WV WORKS and are employed.
