

LOCHHRA EXECUTIVE SUMMARY

February 2020

- For February 2020, WV WORKS cases statewide decreased to **6,453**, down **25** cases compared to January 2020's **6,478** cases.
- Adult WV WORKS cases statewide for February 2020 are **1,644**, down **41** cases compared to January 2020's **1,685** cases.
- Child-only cases statewide for February 2020 are **4,809**, up **16** cases compared to January 2020's **4,793** cases.
- Total support service payments for February 2020 totaled **\$227,427**, down **\$5,459** from January 2020's **\$232,886**.
- From December 1st, 2001 through February 29th, 2020, **3,404** WV WORKS cases have closed due to the adult(s) reaching the 60-month limit. Of that amount, **2,002** customers requested an extension of benefits up to an additional 6-month period; **859** of which were approved (for a **43.0%** approval rate).

Characteristics of the Current WV WORKS Caseload

February 2020

- √ **4,809** Child-only cases ---- parents not in the home and children living with a relative, or parents in the home, are receiving Medicaid and are excluded from the WV WORKS payment.

- √ **94** Cases currently receiving WV WORKS and received TANF in another state before moving to West Virginia.

- √ **122** Cases where parents are excluded from the payment due to being convicted of a drug-related felony after August 22, 1996.

- √ **6,607** Cases receiving Medicaid but not SNAP.

- √ **203** Cases receiving SNAP but adults not receiving Medicaid.

- √ **225** Adults receiving WV WORKS and are employed.
