

## LOCHHRA EXECUTIVE SUMMARY May 2022

- For May 2022, WV WORKS cases statewide decreased to **5,356**, down **21** cases compared to April 2022's **5,377** cases.
- Adult WV WORKS cases statewide for May 2022 are **1,268**, down **21** cases compared to April 2022's **1,289** cases.
- Child-only cases statewide for May 2022 are **4,088**, down **0** cases compared to April 2022's **4,088** cases.
- Total support service payments for May 2022 totaled **\$152,417**, up **\$16,313** from April 2022's **\$136,104**.

From December 1<sup>st</sup>, 2001, through May 31<sup>st</sup>, 2022, **3,547** WV WORKS cases have closed due to the adult(s) reaching the 60-month limit of that amount, **2,070** customers requested an extension of benefits up to an additional 6-month period; **891** of which were approved (for a **43.0%** approval rate).
