### LOCHHRA EXECUTIVE SUMMARY January 2023

- For January 2023, WV WORKS cases statewide decreased to **5,237**, down **4** cases compared to December 2022's **5,241** cases.
- Adult WV WORKS cases statewide for January 2023 are **1,367**, up **0** cases compared to December 2022's **1,367** cases.
- Child-only cases statewide for January 2023 are **3,870**, down **4** cases compared to December 2022's **3,874** cases.
- Total support service payments for January 2023 totaled \$185,163, up \$11,957 from December 2022's \$173,206.

From December 1<sup>st</sup>, 2001, through January 31st, 2023, **3,575** WV WORKS cases have closed due to the adult(s) reaching the 60-month limit of that amount, **2,078** customers requested an extension of benefits up to an additional 6-month period; **893** of which were approved (for a **43.0**% approval rate).
