

LOCHHRA EXECUTIVE SUMMARY

March 2023

- For March 2023, WV WORKS cases statewide decreased to **5,193**, down **26** cases, compared to February 2022's **5,219** cases.
- Adult WV WORKS cases statewide for March 2023 are **1,310**, down **25** cases, compared to February 2022's **1,335** cases.
- Child-only cases statewide for March 2023 are **3,883**, down **1** case, compared to February 2022's **3,884** cases.
- Total support service payments for March 2023 totaled **\$191,123**, up **\$19,785** from February 2022's **\$171,338**.

From December 1st, 2001, through March 31st, 2023, **3,581** WV WORKS cases have closed due to the adult(s) reaching the 60-month limit of that amount, **2,083** customers requested an extension of benefits up to an additional 6-month period; **893** of which were approved (for a **42.9%** approval rate).
