

## LOCHHRA EXECUTIVE SUMMARY April 2024

- For April 2024, WV WORKS cases statewide decreased to **4,827**, down **115** cases, compared to March 2024's **4,942** cases.
- Adult WV WORKS cases statewide for April 2024 are **1,287**, down **55** cases, compared to March 2024's **1,342** cases.
- Child-only cases statewide for April 2024 are **3,540**, down **60** cases, compared to March 2024's **3,600** cases.
- Total support service payments for April 2024 totaled **\$172,244**, up **\$16,588** from March 2024's **\$155,656**.

From December 1<sup>st</sup>, 2001, through April 30th, 2024, **3,631** WV WORKS cases have closed due to the adult(s) reaching the 60-month limit of that amount, **2,103** customers requested an extension of benefits up to an additional 6-month period; **903** of which were approved (for a **42.9%** approval rate).

**Beginning April 2024 WV Works Case Data comes from OAMR Monthly Reports and is corrected from January 2024.**
