

## LOCHHRA EXECUTIVE SUMMARY

### August 2024

- For August 2024, WV WORKS cases statewide increased to **4,682**, up **34** cases, compared to July 2024's **4,648** cases.
- Adult WV WORKS cases statewide for August 2024 are **1,231**, up **12** cases, compared to July 2024's **1,219** cases.
- Child-only cases statewide for August 2024 are **3,451**, up **22** cases, compared to July 2024's **3,429** cases.
- Total support service payments for August 2024 totaled **\$177,051**, up **\$6,683** from July 2024's **\$170,368**.

From December 1<sup>st</sup>, 2001, through August 31<sup>st</sup>, 2024, **3,644** WV WORKS cases have closed due to the adult(s) reaching the 60-month limit of that amount, **2,106** customers requested an extension of benefits up to an additional 6-month period; **904** of which were approved (for a **42.9%** approval rate).
