

LOCHHRA EXECUTIVE SUMMARY

January 2024

- For January 2024, WV WORKS cases statewide decreased to **4,963**, down **62** cases, compared to December 2023's **5,025** cases.
- Adult WV WORKS cases statewide for January 2024 are **1,290**, down **21** cases, compared to December 2023's **1,311** cases.
- Child-only cases statewide for January 2024 are **3,673**, down **41** cases, compared to December 2023's **3,714** cases.
- Total support service payments for January 2024 totaled **\$172,163**, up **\$7,303** from December 2023's **\$164,860**.

From December 1st, 2001, through January 31st, 2024, **3,619** WV WORKS cases have closed due to the adult(s) reaching the 60-month limit of that amount, **2,099** customers requested an extension of benefits up to an additional 6-month period; **900** of which were approved (for a **42.9%** approval rate).
