

LOCHHRA EXECUTIVE SUMMARY

November 2024

- For November 2024, WV WORKS cases statewide increased to **4,727**, up **0** cases, compared to October 2024's **4,727** cases.
- Adult WV WORKS cases statewide for November 2024 are **1,358**, up **7** cases, compared to October 2024's **1,351** cases.
- Child-only cases statewide for November 2024 are **3,369**, down **7** cases, compared to October 2024's **3,376** cases.
- Total support service payments for November 2024 totaled **\$179,013**, up **\$6,254** from October 2024's **\$172,759**.

From December 1st, 2001, through November 30th, 2024, **3,655** WV WORKS cases have closed due to the adult(s) reaching the 60-month limit of that amount, **2,109** customers requested an extension of benefits up to an additional 6-month period; **907** of which were approved (for a **43.0%** approval rate).
