LOCHHRA EXECUTIVE SUMMARY April 2025

- For April 2025, WV WORKS cases statewide decreased to 4,646, down 18 cases, compared to March 2025's 4,664 cases.
- Adult WV WORKS cases statewide for April 2025 are **1,315**, up **5** cases, compared to March 2025's **1,310** cases.
- Child-only cases statewide for April 2025 are **3,331**, down **23** cases, compared to March 2025's **3,354** cases.
- Total support service payments for April 2025 totaled \$198,726, up \$22,825 from March 2025's \$175,901.

From December 1st, 2001, through April 30th, 2025, **3,668** WV WORKS cases have closed due to the adult(s) reaching the 60-month limit of that amount, **2,121** customers requested an extension of benefits up to an additional 6-month period; **912** of which were approved (for a **43.0**% approval rate).
