

## LOCHHRA EXECUTIVE SUMMARY

### February 2025

- For February 2025, WV WORKS cases statewide increased to **4,740**, up **22** cases, compared to January 2025's **4,718** cases.
- Adult WV WORKS cases statewide for February 2025 are **1,353**, down **9** cases, compared to January 2025's **1,362** cases.
- Child-only cases statewide for February 2025 are **3,387**, up **31** cases, compared to January 2025's **3,356** cases.
- Total support service payments for February 2025 totaled **\$149,098**, up **\$56** from January 2025's **\$149,042**.

From December 1<sup>st</sup>, 2001, through March 31<sup>st</sup>, 2025, **3,660** WV WORKS cases have closed due to the adult(s) reaching the 60-month limit of that amount, **2,114** customers requested an extension of benefits up to an additional 6-month period; **910** of which were approved (for a **43.0%** approval rate).
