

LOCHHRA EXECUTIVE SUMMARY

January 2025

- For January 2025, WV WORKS cases statewide decreased to **4,718**, down **52** cases, compared to December 2024's **4,770** cases.
- Adult WV WORKS cases statewide for January 2025 are **1,362**, down **35** cases, compared to December 2024's **1,397** cases.
- Child-only cases statewide for January 2025 are **3,356**, down **17** cases, compared to December 2024's **3,373** cases.
- Total support service payments for January 2025 totaled **\$149,042**, down **\$28,839** from December 2024's **\$177,881**.

From December 1st, 2001, through January 31st, 2025, **3,659** WV WORKS cases have closed due to the adult(s) reaching the 60-month limit of that amount, **2,113** customers requested an extension of benefits up to an additional 6-month period; **909** of which were approved (for a **43.0%** approval rate).
