LOCHHRA EXECUTIVE SUMMARY March 2025

- For March 2025, WV WORKS cases statewide decreased to 4,664, down 76 cases, compared to February 2025's 4,740 cases.
- Adult WV WORKS cases statewide for March 2025 are 1,310, down 43 cases, compared to February 2025's 1,353 cases.
- Child-only cases statewide for March 2025 are **3,354**, down **33** cases, compared to February 2025's **3,387** cases.
- Total support service payments for March 2025 totaled \$175,901, up \$26,803 from February 2025's \$149,098.

From December 1st, 2001, through March 31st, 2025, **3,662** WV WORKS cases have closed due to the adult(s) reaching the 60-month limit of that amount, **2,118** customers requested an extension of benefits up to an additional 6-month period; **912** of which were approved (for a **43.1**% approval rate).
