West Virginia Preferred Diabetic Supply List (PDSL)

Effective 4/1/2019

The West Virginia Medicaid Program has established a Preferred Diabetic Supply List for preferred test strips and sensors. For your convenience, we have provided NDC codes and special instructions for obtaining compatible blood glucose meters. Please note that West Virginia Medicaid does not pay for fingerstick blood glucose meters. Preferred meters will instead be supplied by their manufacturers (<u>Abbott Diabetes Care and Trividia Health Inc.</u>). Instructions for obtaining these meters are located near the end of this document.

Effective April 1st, 2019 West Virginia Medicaid will also cover selected Continuous Glucose Meters (CGM) and the Omnipod Insulin System replacement pods with a prior authorization requirement. Please refer to our website for specific prior authorization criteria
