

Intellectual **Developmental Disabilities Waiver** (IDDW)

A West Virginia Home and **Community-Based Program** 

#### What is the IDDW?

The West Virginia IDDW is a federal and state-funded program for individuals with intellectual and/or developmental disabilities. The IDDW Program reimburses for services to instruct, train, support, supervise, and assist individuals to achieve the highest level of independence possible.

### **Eligibility Requirements**

- Must be ages three or older
- Must have a diagnosis of an intellectual disability and/or related conditions prior to age 22.
- Must have substantial deficits in at least three of the following six areas:
  - Self-care:
  - Receptive or expressive language;
  - Learning;
  - Mobility;
  - Self-direction; or
  - Capacity for independent living
- Person's income must be less than three times the maximum monthly supplemental security income (SSI).
- Person must have less than \$2,000 in assets (minus any allowable exclusions).

#### **How to Apply?**

- Request an application (WVBMS I/DD-01) information packet from Acentra Health by calling 1-866-385-8920.
- The applicant and/or legal representative must complete the application and submit it to Acentra Health by fax, email or mail to the address located at the bottom of the application.
- Any West Virginia Department of Human Services (DoHS) local office can assist the applicant to complete the application at no cost.
- The applicant will receive an Independent Psychologist Network (IPN) packet after Acentra Health receives the completed application.
- The applicant and/or legal representative will choose a psychologist within the West Virginia IPN to complete an eligibility evaluation.
- The evaluation is completed and submitted within 60 days of the initial application.
- A final eligibility determination will be made by the West Virginia medical eligibility contract agent within 30 days of receipt based on medical, physical, psychological, and social evaluations of the applicant.

# What are my Due Process Rights?

 Applicants have a right to a full eligibility determination within 90 days of submitting a completed

application.

 If eligibility is denied, the applicant will receive a "Notice of Decision" and "Request for Hearing " form. The applicant may appeal the denial through the fair hearing process and is afforded 90 days to request a hearing.

 Applicants who request a hearing shall be entitled to a final administrative decision within 90

days.

 An applicant has the right to a second medical examination at DoHS's expense, if the denial was based on a medical reason.

 An applicant has the right to access a copy of their file free of

charge.

 DoHS will assist in arranging transportation to the fair hearing, if needed.
