SUBJECT:

Rate Increases for Home and Community-Based Services (HCBS)

The temporary rate increases that were implemented with funds made available through the American Rescue Plan Act (ARPA) will be discontinued on March 31, 2022. The primary purpose of the ARPA temporary rate increases was to assist with the recruitment and retention of HCBS workers during the COVID-19 Public Health Emergency. Provider agencies were required to attest that 85% of the ARPA rate increases would be passed through to direct-care workers.

The table below specifies the HCBS rate changes that will go into effect on April 1, 2022.
