**RE:** Rate Increases

This memo provides details regarding the HCBS rate increases that were announced today by Governor Justice. The purpose of these increases is to support provider agencies' efforts to recruit and retain an adequate workforce of direct-care and clinical staff. Policy changes regarding financial decisions will be forthcoming.

The methodology for determining the new rates is outlined in the Rates Study Report which was distributed in December 2023. I want to thank the provider agencies and other stakeholders that participated in the rates study.
