The individual also had experience with administering naloxone to a friend who had experienced an overdose. All the stigma messaging was going through the Help&HopeWV.org and related StigmaFreeWV webpages. Marsha would be included in these meetings going forward. Discussion was had on additional testimonials on naloxone administration for the media campaign.

### Strategic Plan review and approval

The Subcommittee reviewed the public comments on Goal 1 of the draft Year 2 Action plan and evaluated potential changes. StigmaFreeWV had the ability to host the stigma training database. ODCP was to survey Subcommittee members to identify target populations.
