- Goal 2, Strategy 1, KPI 1: 75%, Roads to Wellness study is providing this information.
- Goal 2, Strategy 1, KPI 2: 75%, Roads to Wellness study also contributing to these conversations.
- Goal 3, Strategy 1, KPI 1: 75%, Ashley Payne has done a training at the Putnam Chamber.

- Goal 3, Strategy 1, KPI 2: 50%, they are awaiting a grant for official designation of recovery employers.
- Goal 3, Strategy 1, KPI 3: 10%, Deb Harris is reaching out to Goodwill and WorkForce representatives about scheduling a second chance job fair.
- Goal 3, Strategy 2, KPI 1: 50%, Alyce Almond was not able to attend this meeting but has some recourses she can provide. Ashley Alford Glance is sending Ashley Payne her resources with Operation Hope for small business incubation. Jay Phillips provided some more contacts to Ashley Payne.
- Goal 3, Strategy 2, KPI 2: 50%, CORE has some small business workshops coming up.
- Goal 3, Strategy 3, KPI 1: 75%, they just need to meet again before the end of the year.
- Goal 3, Strategy 3, KPI 2: 30%, CORE has not gotten any additional funding, but others on the call have applied and are awaiting information on grants in this space.
