

Meeting Minutes of the Governor's Council on Substance Abuse Prevention and Treatment Transportation and Employment Workgroup September 19, 2023, Approved

Deb Harris provided welcome and opening remarks for this meeting of the Governor's Council on Substance Abuse Prevention and Treatment, Community Engagement Subcommittee – Transportation and Employment Workgroup. - Discussion on establishing a statewide employer designation for recovery-friendly workplaces, with a focus on creating a menu of options for employers.
- Kristen Tiedeman suggested engaging larger employers and targeting Main Street businesses for the recovery-friendly designation.
