Opening:

Chief Shawn Schwertfeger (chair) provided welcome and opening remarks of this meeting of the Governor's Council on Substance Abuse Prevention and Treatment, Law Enforcement Subcommittee. The meeting was called to order on Tuesday December 10, 2024, and was conducted by Zoom conference. A quorum was present to approve the October and November 2024 meeting minutes. Jason Milton made the motion for approval and Misty Atkins seconded the motion. There was no further discussion. The motion passed with all in favor, and none opposed. Agenda Items:

Review 2024 Accomplishments, State Plan 2025, and Introduction Paragraph

- The group approved of the existing introduction paragraph for their section of the 2025 Plan.

December 18th Meeting of the Governor's Council

- Bradley McCoy provided an overview of the plan for the December 18th governor's council meeting. The group has already finalized their section of the 2025 State Plan and sent in their accomplishments and topics of discussion.

Q4 KPI Progress

- Goal 1, Strategy 1, KPI 1: 75% complete, Lata Menon and Errol Randle could speak to this more. While this training is occurring elsewhere via providers and community organizations, it is not specifically being done by this subcommittee. This category of training will be covered by CIT training in the future though and in next year's plan.
- Goal 1, Strategy 1, KPI 2: 60% complete.
- Goal 2, Strategy 1, KPI 1: 100% complete, Justin Smith has developed messaging around the usage of EMS data so that law enforcement are not as burdened with data and are aware of current procedures and Chief Schwertfeger has forwarded this communication to the appropriate listserv.
- Goal 1, Strategy 1, KPI 2: 100% complete, ODMAP is ongoing with spike alerts directed to all users, QRT members, and regional coordinators. Justin Smith is asking Jack Luikart,

Director at WV Fusion, about how it is being used at the state level. Preliminary data shows a statewide decrease in overdoses and even greater decrease in Wheeling specifically.

- Goal 3, Strategy 1, KPI 1: 100% complete, Lata Menon has trained over 280 officers, and they have hit their goal of 400 officers trained.
- Goal 3, Strategy 1, KPI 2: 100% complete.
- Goal 3, Strategy 1, KPI 3: 100% complete.
