- II. **Approval of Minutes:** Meeting minutes were deferred to March.
- III. **Review of Quarter 4 Progress** – KPI1 100%. KPI2 Routes to Recovery has expanded and there is opportunity to expand more. They are in Kanawha, Wood, Cabell, Wayne. KPI3-still needs some work, it is falling behind. KPI4-no progress made. KPI5-100%, KPI6-90%. Do we have documentation proving that? Should there be a new KPI for new research and ideas?
- IV. **Additional Discussion:**
- Transportation in WV Update- There are facilities that are trying to get a mobile treatment started instead of focusing on transportation to the facility. Modivcare partners with Jobs and Hope WV for statewide transportation. It covers around 90%. There are individuals who have been hired on specifically for Jobs and Hope. SOAR-due to the miles being covered, they are adding a change order for 2 million plus to the transportation grant. CORE-still continuing to work with Recovery Point with Routes to Recovery. ARC- program has been extended. Modivcare-still adding transportation providers in the more rural areas. Mass Transit is around 50% right now and the goal is 100%. Jobs and Hope WV-working closely with Modivcare and are expanding the mass transit. There is a meeting coming up with FirstChoice, Modivcare, and Jobs and Hope to figure out for transportation for treatment and reimbursement for those transporting people to and from treatment. The goal is to develop a list so its easily accessible for people to utilize different forms of transportation. Still working with Good News Garage for the car donation program and Keys to Success. AFA-if you know anyone who wants to start a transportation business, send them the AFA grant qualifications.
 - Survey Progress – sent survey to Reverend Allen for the Council of Churches newsletter but it has not run yet. It has also been sent out to treatment providers so hopefully we will hear something soon.
 - Transportation Video - Public Awareness of Transportation Options-This will explain all the options for transportation and how to qualify.
 - Recovery Community Transportation Network -Rachel and Deb met with Modivcare and FirstChoice to brian storm solutions for helping people get to and from treatment. There will be another meeting in a few weeks to discuss what will happen moving forward. Sarah and Randall have been studying a mobility management model out of Ohio. There is an individual who is a one stop shop for modes of transportation in the region. July of last year Sarah and Randell filed a 5310 and hired a driver. They soon found out that the trips they were doing would have been handled by a different mode already. They are looking for ideas now on how to cover the gap.
 - Issues or Concerns –Can facilities only take people that are being transported by Modivcare? There was a bed and transportation, but the facility refused her because she was not being transported by Modivcare. The facility is in Morgantown, Bev will get the facility information and share with everyone
