Chief Shawn Schwertfeger (Chair) provided welcome and opening remarks of this meeting of the Governor's Council on Substance Abuse Prevention and Treatment, Law Enforcement Subcommittee. 2025 KPI Updates and Performance Management Spreadsheet Review and Quarterly Progress Reporting

- Goal 1, Strategy 1, KPI 1: 100%, The Crisis Intervention Training (CIT) Summit is occurring
 this month on June 23-June 25, 2025. 200 plus are registered with a few seats left. There
 will be a Handle With Care training session at the Summit. CIT Training is also occurring
 in Wyoming County. An 8-hour abridged version of community CIT training is occurring in
 Martinsburg.
- Goal 1, Strategy 1, KPI 2: 50%, Lata Menon will track attendance and completion as these June trainings occur.
- Goal 2, Strategy 1, KPI 1: 50%, Justin Smith provides ongoing support and automatic updates.
- Goal 2, Strategy 1, KPI 2: 50%, There have been 22 spike alerts so far this year.
- Goal 2, Strategy 1, KPI 3: 50%, Justin Smith is working with Errol Randle to put together a
 presentation integrating ODMAP with his existing training. ODMAP training and
 reminders will also be presented at the CIT Summit.
- Goal 3, Strategy 1, KPI 1: 50%, Beth Bailey is doing emotional intelligence (EQ) training in Wyoming County in August. She is also presenting at fall conferences as well that will not be SIM-specific but about mental health and community policing. There will be some SIM-related things at the CIT Summit as well in partnership with Southern Highlands.

Lata Menon is looking for SIM facilitators and will ask for participants at the CIT Summit. They will have a training of trainers later this year for SIM training.

- Goal 3, Strategy 1, KPI 2: 50%, They will document all present at the June trainings.
- Goal 4, Strategy 1, KPI 1: 50%, Misty Atkins is presenting at the Monongalia County Summer School Conference so between 200 and 300 people will be trained in Handle With Care depending on session attendance.
- Goal 4, Strategy 1, KPI 2: 50%, It is pending completion of KPI 1.
